#### Purpose, Scope and Basis

#### **Objective**

#### Article 1

The purpose of this procedure is to determine the principles regarding the implementation stages of the Graduation Project course that University of Kyrenia, Maritime Vocational School students are obliged to take in the 4th semester.

#### Scope

#### Article 2

These principles cover the procedures and principles regarding the implementation of the Graduation Project course in the 8th semester for the students at the University of Kyrenia, Maritime Vocational School and the related provisions.

#### **Basis**

#### Article 3

These principles have been prepared for the students at the Maritime Vocational School at the University of Kyrenia.

#### **Preparation Phase**

#### **Appointment of Advisor and Determination of Graduation Project Topic**

#### Article 4

Each student enrolled in the Graduation Project course is assigned to a project advisor from among the vocational school members by the department head. The process of assigning an advisor is completed no later than 2 weeks after the date announced as the start date of the courses in the academic calendar. The Graduation Project advisor guides the student in determining the subject of study, directing and supervising the work to be done by the student, organizing the work in the form of a project report and evaluating the work. The advisor ensures

that the student adheres to the work schedule and takes the necessary measures to prevent delays that may occur.

#### **Article 5**

Each student is assigned a graduation project topic to be decided by the advisor together with the student. The project topic must be related to the discipline of Maritime Vocational School Studies. More than one student can be assigned a group project, but the number of students in the group cannot be more than 5.

#### Article 6

The project advisor submits the "Graduation Project Application Form" (Annex-1) to the Head of the Department.

#### Article 7

The Graduation Project is prepared in the semester specified in the relevant course plan and/or before, the subject is determined, started and delivered in the specified semester.

#### **Article 8**

The project advisor makes the necessary warnings and supervision to ensure that the student acts in accordance with ethical rules during the realization of the project and the writing of the project report, especially to avoid attempts that may be considered plagiarism.

#### Article 9

In the writing of the Graduation Project report, the rules specified in the Maritime Vocational School Graduation Project Application Procedure will be followed (Annex-3: Graduation Project Writing Guide and Sample Format). The report must be written in easy-to-understand English in accordance with the spelling rules. The maximum acceptable similarity in the similarity or plagiarism report (to be created via Turnitin) will be applied as 30% acceptance rate. The plagiarism report and application criteria are made by the project advisors and those below this rate are eligible to present.

#### Article 10

The mid-term *(midterm)* grade for the Graduation Project course is evaluated by the advisor during the mid-term exam week. In determining the mid-term grade, the students' effort and progress reports are considered in the realization of the project.

#### **Project Defense**

#### Article 11

The project defense is oral and is held in front of a jury of at least 3 or at most 5 people, one of whom is the student's advisor, and the exam juries are announced on the vocational school web page in the 12th week at the latest. The student is obliged to submit the electronic (soft) copy of the report to the relevant jury members 10 days before the exam date at the latest. At the end of the defense, the jury evaluates the thesis. At the end of this evaluation, changes may be requested, they may be found completely inadequate, or they may be found appropriate and graded. If changes are requested, these changes are completed within the period determined by the jury and the report is submitted again to the advisor for approval.

#### Article 12

The evaluation of the Graduation Project course consists of a 15-minute oral presentation and a 5-minute question and answer session. The oral presentation is open to the participation of vocational school students. Participation of all students taking the Graduation Project course is mandatory. Students who do not present their Graduation Project to the jury on the announced date are considered not to have taken the final exam of the course.

#### **Submission of Project Report**

#### **Article 13**

After the report of the Graduation Project course is written in accordance with the rules and after the approval of the advisor and the jury, one (1) copy (hard copy) is submitted to the Head of the Department in clamshell files. The approved and signed final version is sent

electronically *(soft)* to the advisor and the head of the department by e-mail. The deadline for submission of the projects is the start date of the final exams of the semester.

#### Article 14

The final exam grade given by the jury is entered into the student information system by the student's advisor. In case of material errors in grades and objections to exam results, the conditions specified in the University of Kyrenia Associate and Undergraduate Education and Training Regulations apply.

#### Article 15

Graduation projects that do not receive a passing grade within the framework of the evaluation criteria of the Graduation Project course will fail. In this case, the course is repeated within the framework of the education and training regulations to which the student is subject.

#### **Graduation Project Writing Guide and Sample Format**

The following graduation project writing guide is prepared in accordance with APA7 format.

#### **APA 7 Format**

The APA (American Psychological Association) style is a widely used writing and citation system in academic writing, primarily for referencing sources in the social sciences, business, and education disciplines. The 7th edition of the APA Publication Manual was published in 2019, and it provides guidelines for writing, formatting, and citing sources in a consistent and professional manner. Below is an overview of the key aspects of APA 7 format:

#### **General Formatting Rules**

- Page Layout: Use standard 8.5 x 11-inch paper with 1-inch margins on all sides.
- Font Style and Size: Use readable fonts like Times New Roman (12pt), Calibri (11pt), or Arial (11pt).
- **Line Spacing:** Double-space the entire document, including headings, references, and block quotations.
- Page Numbers: Add page numbers in the top right corner of every page, starting from the title page.
- Paragraphs: Indent the first line of each paragraph by 0.5 inches.

- **Direct Quotes:** Include the page number (e.g., "..." (Smith, 2020, p. 45)).

#### **Reference List**

- The reference list should start on a new page with the title "References" bolded and centered at the top.
- Use a hanging indent for all references.
- Arrange references alphabetically by the author's last name.
- Include all sources cited in the text, and ensure they are formatted properly based on the source type (e.g., books, journal articles, websites).

#### **Key Changes in APA 7**

- **Number of Authors in Citations:** For in-text citations with three or more authors, list only the first author followed by "et al." (e.g., Smith et al., 2020).
- DOIs and URLs: Include DOIs in reference entries as clickable URLs (e.g., <a href="https://doi.org/xxxx">https://doi.org/xxxx</a>). Omit "Retrieved from" before URLs unless a retrieval date is necessary.
- **Use of Singular "They":** APA 7 encourages the use of "they" as a singular pronoun to promote inclusivity.
- **Student-Specific Guidelines:** APA 7 provides additional guidelines tailored to student papers, such as different title page requirements.


